***NEW INSTRUMENTS REQUIRE AUTOMATIC DEBIT**

- **Damage to instruments not exceeding normal wear and tear will be repaired by Rush's Music at no charge to you.** Any damage resulting from mistreatment or excessive wear and tear will be your responsibility. Any missing parts or pieces that were included with the instrument, including, but not limited to, mouthpiece, ligature, neck strap, drumsticks, practice pads, mallets and/or bell or snare stands, will be your responsibility.
- Theft coverage includes breaking and entering with a police report only. Theft coverage does not cover damages.
- There will be a \$10 swap fee to change instruments.
- Rent is pre-paid in 3 month periods, and is non-refundable and non-proratable. Any rental payment 30 days past due will be subject to a \$5 late fee per month. Any rental account that is 30 or more days past due may be subject to instrument pickup and/or collections process. All checks returned as non-sufficient funds will be charged a \$30.00 fee.
- Up to nine months of your rent (minus the premium for new rentals and applicable sales tax) may be applied to the purchase of a new or used instrument (only of the types of instruments rented above). Rush's reserves the right to increase this amount of credit, if purchasing a more expensive instrument than the type rented, and to decrease the credit, if purchasing a less expensive instrument than the type rented.

I hereby agree in the event of default on any rental payment due, Rush's Musical Services, Inc may take possession of their rented instrument where ever the same may be found without notice to me, the renter, and without liability to me, the renter, and without prejudice to any legal remedies of Rush's Music, and further, in the event Rush's Music turns the matter of collection of the amount owed hereunder and/or repossession of the instrument over to an attorney or collection agency, that Rush's Music shall be entitled to its reasonable attorney fees, court costs, and thirty-five percent collection fee. Rush's Music owns and retains title to the instrument. If you declare bankruptcy, the instrument must be returned to Rush's Music immediately. Also, in such case, I authorize Rush's Music to charge any past dues fees and late charges to my credit card.
